# DMCC - Company Formation Dubai

The DMCC Free Zone was initially established (in 2002) for the purpose of hosting commodities businesses and those sectors relating to commodities.

JLT (Jumeirah Lakes Towers) Free Zone (also established in 2002) was set up to host non-commodities related industries (in the same area as the DMCC Free Zone), such as Finance, Logistics, Consulting and Insurance.

The DMCC Authority previously offered the two above types of licenses, however since February 2014, the DMCC authority licenses all activities under the one DMCC license.

The DMCC Free Zone is the largest and fastest growing Free Zone in the UAE, with over 14,000 companies registered and there are circa 170 companies being established every month. It has been awarded the Global Free Zone of the Year by the Financial Times fDi magazine for three years in a row.

The DMCC Free Zone is located in Jumeirah Lakes Towers, which is a central location in Dubai and with easy access directly from Sheikh Zayed Road, the main highway going through Dubai.

It is rated 'A' by Standard & Poor's and provides an industry-specific market infrastructure with a full range of facilities for the gold & precious metals, diamonds and coloured stones, energy and other commodities industries.
